Former oil field set to become a vibrant coastal preserve

#### WHAT:

The 387-acre Randall Preserve—a former oil field now undergoing remediation—is entering its next phase. A series of open house events will invite the public to share ideas, ask questions, and help shape plans for a resilient, accessible, and ecologically vibrant coastal preserve.

The project is led by the **Coastal Corridor Alliance** in partnership with the **Mountains Recreation** and **Conservation Authority (MRCA)** and planning team **Dudek**. Together, they aim to ensure the Preserve reflects community needs and long-term environmental goals.
